





# DSWD DROMIC Report on the Effects of Localized Thunderstorms in Brgy. Inaon, Pulilan, Bulacan

30 June 2024, 6PM

#### I. Situation Overview

Issued on 05 June 2024 at 4:00 AM, partly cloudy to cloudy skies with isolated rainshowers or thunderstorms caused by localized thunderstorms may have brought possible flash floods or landslides during severe thunderstorms in Metro Manila and the rest of the country.

On the same day at around 2:00 PM, isolated rainshowers with lightning strikes were experienced in Brgy. Inaon, Pulilan, Bulacan due to localized thunderstorms that resulted in the demise of the individuals.
