I. Situation Overview

On 11 June 2024 at around 2:30 PM, a fire incident occurred in, Brgy. Banga, Candoni, Negros Occidental. The fire was declared out at around 4:05 PM.

III. Status of Displaced Population

Outside Evacuation Center
One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Banga, Candoni, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P6,610.00** worth of assistance was provided to the affected family; of which, **P1,610.00** from **DSWD** and **P5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
