I. Situation Overview

On 20 May 2024 at around 8:10 AM, a fire incident occurred in Brgy. Banica, Roxas City, Capiz. The fire was declared out at around 9:00 AM.

A total of three (3) families or nine (9) persons were affected in Brgy. Banica, Roxas City, Capiz (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **three (3) families** or **nine (9) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of three (3) houses were totally damaged in Brgy. Banica, Roxas City, Capiz (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱70,752.00 worth of assistance was provided to the affected families; of which, ₱25,752.00 from DSWD and ₱45,000.00 from the Local Government Unit (LGU) (see Annex D).
