I. Situation Overview

On 24 May 2024 at around 10:00 AM, a fire incident occurred at Brgy. Bato, Panay, Capiz. The fire was declared out at around 11:00 AM.

One (1) house was totally damaged in Brgy. Bato, Panay, Capiz (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱15,416.00** worth of assistance was provided to the affected families; of which, **₱8,416.00** from **DSWD** and **₱7,000.00** from the **Local Government Unit (LGU)** (see Annex D).
