I. Situation Overview

On 02 June 2024 at around 8:23 AM, a fire incident occurred in Purok 2, Brgy. Cabagohan, Batad, Iloilo. The fire was declared out at around 9:10 AM.

One (1) family or seven (7) persons were affected in Brgy. Cabagohan, Batad, Iloilo (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or seven (7) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Cabagohan, Batad, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P6,918.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
