

DSWD DROMIC Report on the Fire Incident in Brgy. Carol-an, City of Kabankalan, Negros Occidental

30 July 2024, 6PM

I. Situation Overview

On 14 June 2024 at around 8:30 AM, a fire incident occurred in Brgy. Carol-an, City of Kabankalan, Negros Occidental. The fire was declared out at around 9:45 AM.

One (1) family or eight (8) persons were affected in **Brgy. Carol-an, City of Kabankalan, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or eight (8) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in **Brgy. Carol-an, City of Kabankalan, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱11,927.78** worth of assistance was provided to the affected families; of which, **₱6,927.78** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
