

## **DSWD DROMIC Report on the Fire Incident in Brgy. Cortes, Balete, Aklan**

04 July 2024, 6PM

### **I. Situation Overview**

On 20 May 2024 at around 3:40 PM, a fire incident occurred at Sitio Bota, Brgy. Cortes, Balete, Aklan. The fire was declared out at around 5:00 PM.
