I. Situation Overview

On 08 June 2024 at around 10:10 AM, a fire incident occurred in Brgy. Ermita, Dumangas, Iloilo. The fire was declared out at around 11:40 AM.

One (1) house was totally damaged in Brgy. Ermita, Dumangas, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P9,548.88** worth of assistance was provided by the **DSWD** to the affected family (see Annex D).
