I. Situation Overview

On 27 June 2024 at around 2:00 PM, a fire incident occurred in Brgy. Intaluan, Pototan, Iloilo. The fire was declared out at around 2:30 PM.

Outside Evacuation Center

One (1) family or **three (3) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was partially damaged in **Brgy. Intaluan, Pototan, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P8,331.44** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
