

## DSWD DROMIC Report on the Fire Incident in Brgy. Intaluan, Pototan, Iloilo

10 July 2024, 6AM

### I. Situation Overview

On 27 June 2024 at around 2:00 PM, a fire incident occurred in Brgy. Intaluan, Pototan, Iloilo. The fire was declared out at around 2:30 PM.
