I. Situation Overview

On 18 June 2024 at around 10:44 AM, a fire incident occurred in Brgy. Jalaud, Boratoc Nuevo, Iloilo. The fire was declared out at around 11:30 AM.

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Jalaud, Boratoc Nuevo, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱6,623.44** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
