



DSWD DROMIC Report on the Fire Incident in Brgy. Juanico, Banate, Iloilo

01 July 2024, 6PM

I. Situation Overview

On 27 April 2024 at around 6:00 PM, a fire incident occurred at Brgy. Juanico, Banate, Iloilo. The fire was declared out at around 7:00 PM.

One (1) family or **five (5) persons** were affected in **Brgy. Juanico, Banate, Iloilo** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **five (5) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Juanico, Banate, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱5,665.00 worth of assistance was provided to the affected families; of which, ₱665.00 from DSWD and ₱5,000.00 from the Local Government Unit (LGU) (see Annex D).
