I. Situation Overview

On 27 April 2024 at around 6:00 PM, a fire incident occurred at Brgy. Juanico, Banate, Iloilo. The fire was declared out at around 7:00 PM.

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Juanico, Banate, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱5,665.00** worth of assistance was provided to the affected families; of which, **₱665.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
