I. Situation Overview

On 30 June 2024 at around 10:58 AM, a fire incident occurred at Purok Bliss, Brgy. Kinabuan, Dupax del Sur, Nueva Vizcaya.

III. Damaged Houses

One (1) house was totally damaged in Brgy. Kinabuan, Dupax del Sur, Nueva Vizcaya (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of ₱36,292.79 worth of assistance was provided to the affected family; of which, ₱34,992.79 from DSWD and ₱1,300.00 from the Local Government Unit (LGU) (see Annex C).
