I. Situation Overview

On 19 June 2024 at around 2:00 AM, a fire incident occurred in Brgy. Lumbia, Estancia, Iloilo. The fire was declared out at around 4:00 AM.

A total of **two (2) families** or **five (5) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** was **totally damaged** and **one (1)** was **partially damaged** in **Brgy. Lumbia, Estancia, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱13,470.88** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
