02 July 2024, 6AM

I. Situation Overview

On 27 April 2024 at around 6:00 PM, a fire incident occurred in Brgy. Magdalo, Banate, Iloilo. The fire was declared out at around 7:00 PM.

A total of **two (2) families** or **nine (9) persons** were affected in **Brgy. Magdalo**, **Banate**, **Iloilo** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **nine (9) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of two (2) houses were damaged; of which, one (1) is totally damaged and one (1) is partially damaged in Brgy. Magdalo, Banate, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P8,995.00** worth of assistance was provided to the affected families; of which, **P1,995.00** from **DSWD** and **P7,000.00** from the **Local Government Unit (LGU)** (see Annex D).
