





# DSWD DROMIC Report on the Fire Incident in Brgy. Mandalagan, Bacolod City, Negros Occidental

11 July 2024, 6AM

#### I. Situation Overview

On 15 June 2024 at around 11:30 AM, a fire incident occurred in Brgy. Mandalagan, Bacolod City, Negros Occidental. The fire was declared out at around 1:45 PM.

# II. Status of Affected Areas and Population

A total of 11 families or 46 persons were affected in Brgy. Mandalagan, Bacolod City, Negros Occidental (see Annex A).

# III. Status of Displaced Population

#### **Outside Evacuation Center**

A total of **11 families** or **46 persons** temporarily stayed with their relatives or friends (see Annex B).

# IV. Damaged Houses

A total of three (3) houses were damaged; of which, two (2) are totally damaged and one (1) is partially damaged in Brgy. Mandalagan, Bacolod City, Negros Occidental (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **₱131,098.00** worth of assistance was provided to the affected families; of which, **₱79,098.00** from **DSWD** and **₱55,000.00** from the **Local Government Unit (LGU)** (see Annex D).
