I. Situation Overview

On 27 June 2024 at around 1:20 AM, a fire incident occurred at Catoera St. Brgy. Poblacion, Bingawan, Iloilo. The fire was declared out at around 3:15 AM.

One (1) house was totally damaged in Brgy. Poblacion, Bingawan, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P8,584.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
