I. Situation Overview

On 11 May 2024 at around 2:00 AM, a fire incident occurred at Purok 5, Brgy. Puguin, Conner, Apayao.

One (1) house was **totally damaged** in **Brgy. Puguin, Conner, Apayao** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱59,275.16** worth of assistance was provided to the affected family; of which, **₱28,675.16** from **DSWD** and **₱30,600.00** from the **Local Government Unit (LGU)** (see Annex C).
