I. Situation Overview

On 15 May 2024 at around 6:00 AM, a fire incident occurred in Brgy. Santiago, Barotac Viejo, Iloilo. The fire was declared out at around 6:30 AM.

One (1) family or two (2) persons were affected in Brgy. Santiago, Barotac Viejo, Iloilo (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **two (2) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Santiago, Barotac Viejo, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P13,584.00** worth of assistance was provided to the affected families; of which, **P8,584.00** from **DSWD** and **P5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
