

## DSWD DROMIC Report on the Fire Incident in Brgy. Santo Domingo, Iloilo City

05 July 2024, 6AM

### I. Situation Overview

On 23 May 2024 at around 1:37 AM, a fire incident occurred in Brgy. Santo Domingo, Iloilo City. The fire was declared out at around 2:51 AM.

A total of **four (4) families** or **11 persons** were affected in **Brgy. Santo Domingo, Iloilo City** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

A total of **four (4) families** or **11 persons** temporarily stayed with their relatives (see Annex B).

### IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** is **totally damaged** and **one (1)** is **partially damaged** in **Brgy. Santo Domingo, Iloilo City** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱38,477.17** worth of assistance was provided to the affected families; of which, **₱32,203.52** from **DSWD** and **₱6,273.65** from the **Local Government Unit (LGU)** (see Annex D).
