





# DSWD DROMIC Report on the Fire Incident in Brgy. Talagacay, Hinoba-an (Asia), Negros Occidental

05 July 2024, 6AM

#### I. Situation Overview

On 19 May 2024 at around 6:00 PM, a fire incident occurred in Brgy. Talagacay, Hinoba-an (Asia), Negros Occidental. The fire was declared out at around 7:10 PM.

One (1) family or seven (7) persons temporarily stayed with their relatives (see Annex B).

# IV. Damaged Houses

One (1) house was totally damaged in Brgy. Talagacay, Hinoba-an (Asia), Negros Occidental (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of ₱11,416.00 worth of assistance was provided to the affected family; of which, ₱8,416.00 from DSWD and ₱3,000.00 from the Local Government Unit (LGU) (see Annex D).
