





DSWD DROMIC Report on the Fire Incident in Brgy. Tejeros, Makati City

18 July 2024, 6PM

I. Situation Overview

On 01 July 2024 at around 1:14 PM, a fire incident occurred at 1042 A.P. Reyes, Brgy. Tejeros, Makati City. The fire was declared out at around 2:22 PM.

Relative to the incident, the DSWD through its Field Office in the National Capital Region, provided relief augmentation to support the immediate needs of the affected families and individuals.

A total of **eight (8) families** or **25 persons** were affected in **Brgy. Tejeros, Makati City** (see Annex A).

A total of **eight (8) families** or **25 persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of six (6) houses were totally damaged in Brgy. Tejeros, Makati City (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱16,488.36 worth of assistance from **DSWD** was provided to the affected families (see Annex D).
