

DSWD DROMIC Report on the Fire Incident in Brgy. Tejeros, Makati City

18 July 2024, 6PM

I. Situation Overview

On 01 July 2024 at around 1:14 PM, a fire incident occurred at 1042 A.P. Reyes, Brgy. Tejeros, Makati City. The fire was declared out at around 2:22 PM.

Relative to the incident, the DSWD through its Field Office in the National Capital Region, provided relief augmentation to support the immediate needs of the affected families and individuals.

IV. Damaged Houses

A total of **six (6) houses** were **totally damaged** in **Brgy. Tejeros, Makati City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱16,488.36** worth of assistance from **DSWD** was provided to the affected families (see Annex D).
