## DSWD DROMIC Report on the Fire Incident in Brgy. Camiros, Anilao, Iloilo 06 July 2024, 6AM

### I. Situation Overview

On 16 May 2024 at around 8:23 AM, a fire incident occurred in Brgy. Camiros, Anilao, Iloilo. The fire was declared out at around 10:00 AM.
