I. Situation Overview

On 13 June 2024 at around 4:00 PM, a tornado incident occurred in Brgy. Inabasan, Cabatuan, Iloilo.

II. Status of Affected Areas and Population

One (1) family or six (6) persons were affected in Brgy. Inabasan, Cabatuan, Iloilo (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **six (6) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Inabasan, Cabatuan, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱18,050.88 worth of assistance was provided to the affected family; of which, ₱8,050.88 from DSWD and ₱10,000.00 from the Local Government Unit (LGU) (see Annex D).
