

# DSWD DROMIC Terminal Report on the Clan Feud Incident in Brgy. Lomopog, Midsayap, North Cotabato

04 February 2025, 6AM

## I. Situation Overview

On 30 June 2024 at around 3:21 PM, a clan feud (Rido) involving two (2) warring families transpired in Brgy. Lomopog, Midsayap, North Cotabato. The conflict resulted in the displacement of families and persons in the area.

A total of **150 families** or **596 persons** were affected in **Brgy. Lomopog, Midsayap, North Cotabato** (see Annex A).

## III. Status of Displaced Population

### Inside Evacuation Center

A total of **150 families** or **596 persons** sought temporary shelter at the **Lomopog Elementary School** in **Brgy. Lomopog, Midsayap, North Cotabato** (see Annex B).

## IV. Cost of Humanitarian Assistance Provided

A total of **₱881,150.00** worth of assistance was provided to the affected families; of which, **₱868,650.00** from **DSWD** and **₱12,500.00** from the **Local Government Unit (LGU)** (see Annex C).
