### **I. Situation Overview**

On 10 April 2024 at around 2:30 PM, a fire incident occurred in Brgy. Arellano, Quezon, Isabela.

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Arellano, Quezon, Isabela** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱23,537.31** worth of assistance was provided to the affected family composed of **₱13,537.31** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
