

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Bagong Bayan, Bato, Leyte

29 June 2024, 6AM

## I. Situation Overview

On 03 July 2024 at around 11:00 AM, a fire incident occurred in Brgy. Bagong Bayan, Bato, Leyte. The fire was declared out on the same day.

In response, the DSWD through its Field Office in Region VIII, together with the Local Government Unit (LGU) of Bato, Leyte, provided relief and financial assistance to support the immediate needs of the affected family.

A total of **₱19,152.90** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
