

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Balite, Aritao, Nueva Vizcaya

I. Situation Overview

On 30 June 2024 at around 4:00 PM, a fire incident occurred in Brgy. Balite, Aritao, Nueva Vizcaya.

II. Status of Affected Areas and Population

One (1) family or seven (7) persons were affected in Brgy. Balite, Aritao, Nueva Vizcaya (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or seven (7) persons are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Balite, Aritao, Nueva Vizcaya (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of \$\mathbb{P}36,570.28\$ worth of assistance was provided to the affected family composed of \$\mathbb{P}25,270.28\$ from DSWD and \$\mathbb{P}11,300.00\$ from the Local Government Unit (LGU) (see Annex D).
