

## **DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Balite, Aritao, Nueva Vizcaya**

30 January 2025, 6PM

### **I. Situation Overview**

On 30 June 2024 at around 4:00 PM, a fire incident occurred in Brgy. Balite, Aritao, Nueva Vizcaya.

**One (1) family or seven (7) persons** were affected in **Brgy. Balite, Aritao, Nueva Vizcaya** (see Annex A).

### **III. Status of Displaced Population**

#### **Outside Evacuation Center**

**One (1) family or seven (7) persons** are temporarily staying with their relatives or friends (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Balite, Aritao, Nueva Vizcaya** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱36,570.28** worth of assistance was provided to the affected family composed of **₱25,270.28** from **DSWD** and **₱11,300.00** from the **Local Government Unit (LGU)** (see Annex D).
