I. Situation Overview

On 12 July 2024 at around 10:00 AM, a fire incident occurred in Brgy. Banaoang, Malasiqui, Pangasinan.

One (1) family or five (5) persons are temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Banaoang, Malasiqui, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱28,464.14** worth of assistance was provided to the affected family; of which, **₱16,904.14** from **DSWD** and **₱11,560.00** from the **Local Government Unit (LGU)** (see Annex D).
