

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Barangka Itaas, Mandaluyong City

13 January 2025, 6PM

I. Situation Overview

On 27 June 2024 at around 1:57 PM, a fire incident occurred at Natib Street, J. Salinga, Brgy. Barangka Itaas, Mandaluyong City. The fire was declared out at around 2:58 pm.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office in the National Capital Region, promptly initiated response operations and provided relief assistance, including food and non-food items, to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

A total of **19 families** or **77 persons** were affected in **Brgy. Barangka Itaas, Mandaluyong City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **19 families** or **17 persons** sought temporary shelter in **MRR Track Escalon Covered Court** in **Brgy. Barangka Itaas, Mandaluyong City** (see Annex B).

IV. Damaged Houses

A total of **six (6) houses** were **totally damaged** in **Brgy. Barangka Itaas, Mandaluyong City** (see Annex D).

V. Cost of Humanitarian Assistance Provided

A total of **₱82,352.84** worth of assistance was provided by **DSWD** to the affected families (see Annex E).
