

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Central Poblacion, Hilongos, Leyte

04 August 2024, 6PM

I. Situation Overview

On 16 July 2024 at around 8:31 AM, a fire incident occurred at Sitio Kanunay in Brgy. Central Poblacion, Hilongos, Leyte. The fire was declared out at around 9:30 AM.

In response, the DSWD through its Field Office in Region VIII, together with the Local Government Unit (LGU) of Hilongos, Leyte, provided relief and financial assistance to support the immediate needs of the affected family.

One (1) family or four (4) persons were affected in **Brgy. Central Poblacion, Hilongos, Leyte** (see Annex A).

Inside Evacuation Center

One (1) family or four (4) persons sought temporary shelter in **Brgy. Central Poblacion Hall in Hilongos, Leyte** (see Annex B).

IV. Damaged Houses

One (1) house was partially damaged in **Brgy. Central Poblacion, Hilongos, Leyte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱14,096.38** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
