I. Situation Overview

On 26 March 2024 at around 2:07 PM, a fire incident occurred at Purok 7, Brgy. Manano, Mallig, Isabela.

A total of **One (1) family** or **three (3) persons** were affected in **Brgy. Manano, Mallig, Isabela** (see Annex A).

Outside Evacuation Center

A total of **One (1) family** or **three (3) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Manano, Mallig, Isabela (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P32,740.00** worth of assistance was provided to the affected family composed of **P22,740** from **DSWD** and **P10,000.00** from the **Local Government Unit** (**LGU**) (see Annex D).
