I. Situation Overview

On 26 March 2024 at around 2:07 PM, a fire incident occurred at Purok 7, Brgy. Manano, Mallig, Isabela.

A total of **One (1) family** or **three (3) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Manano, Mallig, Isabela** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱32,740.00** worth of assistance was provided to the affected family composed of **₱22,740** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
