

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Maria Cristina, Jaro, Iloilo City

26 September 2024, 6PM

I. Situation Overview

On 30 June 2024 at around 4:16 PM, a fire incident occurred in Brgy. Maria Cristina, Jaro, Iloilo City. The fire was declared out at around 6:07 PM.

II. Status of Affected Areas and Population

A total of **43 families** or **113 persons** were affected in **Brgy. Maria Cristina, Jaro, Iloilo City** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

A total of **five (5) families** or **19 persons** sought temporary shelter at the **Iloilo Baptist Church** in **Iloilo City** (see Annex B).

b. Outside Evacuation Center

A total of **38 families** or **94 persons** temporarily stayed with their relatives or friends (see Annex D).

c. Total Displaced Population

A total of **43 families** or **113 persons** were displaced in **Brgy. Maria Cristina, Jaro, Iloilo City** (see Annex E).

IV. Damaged Houses

A total of **19 houses** were damaged; of which, **15** are **totally damaged** and **four (4)** are **partially damaged** in **Brgy. Maria Cristina, Jaro, Iloilo City** (see Annex F).

V. Cost of Humanitarian Assistance Provided

A total of **₱605,804.82** worth of assistance was provided to the affected families; of which, **₱524,557.92** from **DSWD** and **₱81,246.90** from the **Local Government Unit (LGU)** (see Annex G).
