### I. Situation Overview

On 22 July 2024 at around 4:00 AM, a fire incident occurred in Brgy. Mabini, Macrohon, Southern Leyte.

A total of **two (2) families** or **11 persons** are affected in **Brgy. Mabini, Macrohon, Southern Leyte** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

There are **two (2) families** or **11 persons** temporarily staying with their relatives or friends (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Mabini, Macrohon, Southern Leyte** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱16,641.76** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
