# I. Situation Overview

On 07 August 2024 at around 11:00 PM, a fire incident occurred at Purok 1, Brgy. Tabigue, Kolambugan, Lanao del Norte. The fire was declared out at around 11:36 PM.

# **II.** Status of Affected Areas and Population

A total of two (2) families or four (4) persons are affected in Brgy. Tabigue, Kolambugan, Lanao del Norte (see Annex A).

## **III.** Status of Displaced Population

#### **Outside Evacuation Center**

There are **two (2) families** or **four (4) persons** temporarily staying with their relatives (see Annex B).

## IV. Damaged Houses

A total of two (2) houses were damaged; of which, one (1) is totally damaged and one (1) is partially damaged in Brgy. Tabigue, Kolambugan, Lanao del Norte (see Annex C).

# V. Cost of Humanitarian Assistance Provided

A total of ₱22,472.00 worth of assistance was provided to the affected families; of which, ₱16,472.00 from DSWD and ₱6,000.00 from the Local Government Unit (LGU) (see Annex D).
