

DSWD DROMIC Report #3 on the Fire Incident in Brgy. Campo Filipino, Baguio City

as of 18 September 2024, 6PM

I. Situation Overview

On 27 August 2024 at around 5:30 AM, a fire incident occurred at Gaerlan Street, Brgy. Campo Filipino, Baguio City. The fire was declared out at around 8:12 AM.

II. Status of Affected Areas and Population

A total of **20 families** or **38 persons** are affected in **Brgy. Campo Filipino, Baguio City** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

There are **three (3) families** or **14 persons** currently taking temporary shelter at the **Campo Filipino Brgy. Hall** in **Baguio City** (see Annex B).

b. Outside Evacuation Center

There are **five (5) families** or **15 persons** temporarily staying with their relatives or friends (see Annex D).

c. Total Displaced Population

There are **eight (8) families** or **29 persons** displaced in **Brgy. Campo Filipino, Baguio City** (see Annex E).

IV. Damaged Houses

A total of **seven (7) houses** were damaged; of which, **five (5)** are **totally damaged** and **two (2)** are **partially damaged** in **Brgy. Campo Filipino, Baguio City** (see Annex F).

V. Cost of Humanitarian Assistance Provided

A total of **₱515,859.20** worth of assistance was provided to the affected families composed of **₱317,859.20** from **DSWD** and **₱198,000.00** from the **Local Government Unit (LGU)** (see Annex G).
