

## DSWD DROMIC Report on the Fire Incident in Brgy, Cubay, San Enrique, Iloilo

09 August 2024, 6AM

### I. Situation Overview

On 17 July 2024 at around 10:00 PM, a fire incident occurred in Brgy, Cubay, San Enrique, Iloilo. The fire was declared out at around 11:00 PM.

One (1) person sought temporary shelter at the **Brgy. Hall** in **Brgy. Cubay, San Enrique, Iloilo** (see Annex B).

### IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Cubay, San Enrique, Iloilo** (see Annex D).

### V. Cost of Humanitarian Assistance Provided

A total of **₱18,401.44** worth of assistance was provided to the affected person; of which, **₱8,401.44** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex E).
