

DSWD DROMIC Report on the Fire Incident in Brgy. Banago, Bacolod City, Negros Occidental

07 August 2024, 6PM

I. Situation Overview

On 14 July 2024 at around 7:30 AM, a fire incident occurred in Brgy. Banago, Bacolod City, Negros Occidental. The fire was declared out at around 8:45 AM.

A total of **three (3) families** or **eight (8) persons** were affected in **Brgy. Banago, Bacolod City, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **three (3) families** or **eight (8) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Banago, Bacolod City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱28,636.32** worth of assistance was provided to the affected family; of which, **₱24,136.32** from **DSWD** and **₱4,500.00** from the **Local Government Unit (LGU)** (see Annex D).
