

## **DSWD DROMIC Report on the Fire Incident in Brgy. Bata, Bacolod City, Negros Occidental**

06 August 2024, 6PM

### **I. Situation Overview**

On 01 August 2024 at around 10:30 AM, a fire incident occurred in Brgy. Bata, Bacolod City, Negros Occidental. The fire was declared out at around 11:45 AM.

**One (1) family or five (5) persons** were affected in **Brgy. Bata, Bacolod City, Negros Occidental** (see Annex A).

**One (1) family or five (5) persons** temporarily stayed with their relatives or friends (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **partially damaged** in **Brgy. Bata, Bacolod City, Negros Occidental** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱9,523.44** worth of assistance was provided to the affected family; of which, **₱8,023.44** from **DSWD** and **₱1,000.00** from the **Local Government Unit (LGU)** (see Annex D).

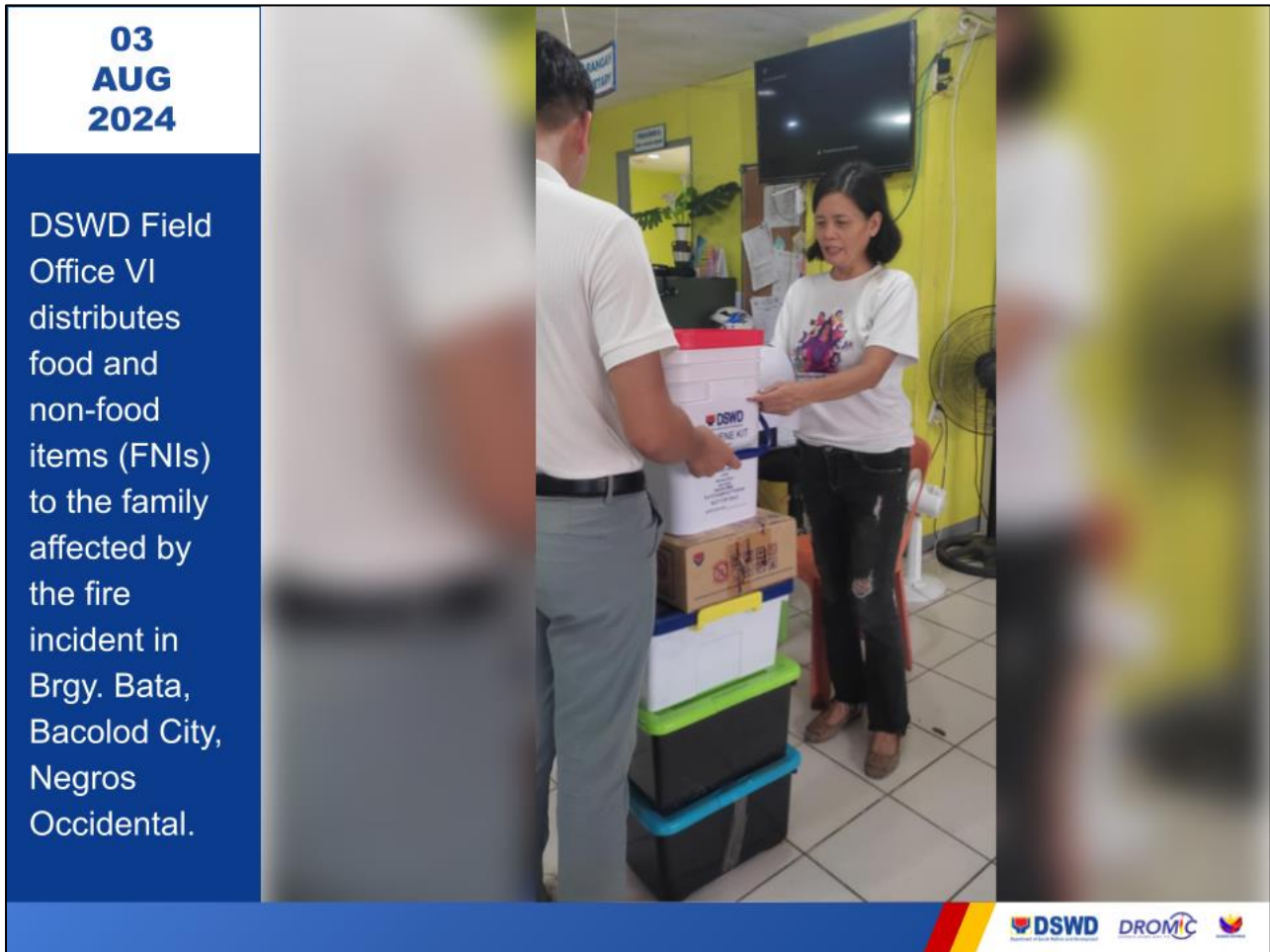
