26 August 2024, 6AM

I. Situation Overview

On 05 August 2024 at around 1:33 PM, a fire incident occurred at Purok 3, Brgy. Chavayan, Sabtang, Batanes. The fire was declared out at around 3:40 PM.

In response, the DSWD through its Field Office in Region II provided relief and financial assistance to support the immediate needs of the affected person.
