





DSWD DROMIC Report on the Fire Incident in Brgy. Consolacion, San Miguel, Iloilo

20 August 2024, 6PM

I. Situation Overview

On 25 July 2024 at around 10:20 AM, a fire incident occurred at Brgy. Consolacion, San Miguel, Iloilo. The fire was declared out at around 11:30 AM.

In response, the DSWD through its Field Office in Region VI promptly provided relief assistance to support the immediate needs of the affected family.
