

## **DSWD DROMIC Report on the Fire Incident in Brgy. Daga, Cadiz City, Negros Occidental**

13 August 2024, 6AM

### **I. Situation Overview**

On 28 July 2024 at around 3:45 PM, a fire incident occurred at Brgy. Daga, Cadiz City, Negros Occidental. The fire was declared out at around 5:15 PM.

Relative to the incident, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Cadiz City, promptly provided relief assistance to address the urgent needs of the affected families.

### **II. Status of Affected Areas and Population**

A total of **nine (9) families** or **38 persons** were affected in **Brgy. Daga, Cadiz City, Negros Occidental** (see Annex A).

### **III. Status of Displaced Population**

#### **Outside Evacuation Center**

A total of **nine (9) families** or **38 persons** temporarily stayed with their relatives or friends (see Annex B).

### **IV. Damaged Houses**

A total of **nine (9) houses** were damaged; of which, **seven (7)** are **totally damaged** and **two (2)** are **partially damaged** in **Brgy. Daga, Cadiz City, Negros Occidental** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱47,564.96** worth of assistance was provided to the affected families composed of **₱29,564.96** from **DSWD** and **₱18,000.00** from the **Local Government Unit (LGU)** (see Annex D).
