## DSWD DROMIC Report on the Fire Incident in Brgy. Dalusan, Maasin, Iloilo

07 August 2024, 6AM

### I. Situation Overview

On 03 July 2024 at around 10:45 AM, a fire incident occurred in Brgy. Dalusan, Maasin, Iloilo. The fire was declared out at around 11:30 AM.
