

## **DSWD DROMIC Report on the Fire Incident in Brgy. Dancalan, Ilog, Negros Occidental**

07 August 2024, 6PM

### **I. Situation Overview**

On 21 July 2024 at around 3:00 PM, a fire incident occurred in Brgy. Dancalan, Ilog, Negros Occidental. The fire was declared out at around 5:30 PM.

A total of **five (5) families** or **nine (9) persons** were affected in **Brgy. Dancalan, Ilog, Negros Occidental** (see Annex A).

### **III. Status of Displaced Population**

#### **Outside Evacuation Center**

A total of **five (5) families** or **nine (9) persons** temporarily stayed with their relatives or friends (see Annex B).

### **IV. Damaged Houses**

A total of **five (5) houses** were **totally damaged** in **Brgy. Dancalan, Ilog, Negros Occidental** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱55,174.40** worth of assistance was provided to the affected families; of which, **₱40,174.40** from **DSWD** and **₱15,000.00** from the **Local Government Unit (LGU)** (see Annex D).
