

DSWD DROMIC Report on the Fire Incident in Brgy. Espinosa, Jordan, Guimaras

13 August 2024, 6AM

I. Situation Overview

On 14 July 2024 at around 7:40 AM, a fire incident occurred in Brgy. Espinosa, Jordan, Guimaras. The fire was declared out at around 8:45 AM.

In response, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Jordan, Guimaras, provided relief assistance to support the immediate needs of the affected family.

One (1) family or **four (4) persons** were affected in **Brgy. Espinosa, Jordan, Guimaras** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **four (4) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Espinosa, Jordan, Guimaras** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,751.00** worth of assistance was provided to the affected family composed of **₱7,751.00** from the **DSWD** and **₱3,000.00** from the **Local Government Unit (LGU)** (see Annex D).
