

DSWD DROMIC Report on the Fire Incident in Brgy. Felisa, Bacolod City, Negros Occidental

I. Situation Overview

On 17 July 2024 at around 7:30 AM, a fire incident occurred in Brgy. Felisa, Bacolod City, Negros Occidental. The fire was declared out at around 9:15 AM.

One (1) family or four (4) persons were affected in **Brgy. Felisa, Bacolod City, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or four (4) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Felisa, Bacolod City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱9,926.00** worth of assistance was provided to the affected family; of which, **₱8,426.00** from **DSWD** and **₱1,500.00** from the **Local Government Unit (LGU)** (see Annex D).
